What is EARHN and why?

- A South-South initiative of government ministries addressing population, RH & development.
- Comprises of Burundi, Ethiopia, Kenya, Rwanda, Tanzania, and Uganda.
- Countries share similar social, political, demographic and geographic environments and challenges.

What are the RH problems?

- High fertility
- High population growth rates superseding economic growth and poverty reduction
- High STI/HIV prevalence
- Poor infant and maternal health indices
- Large numbers of vulnerable adolescents who are often unable to access appropriate information and services.

4. Engage cultural and traditional institutions to address socio-cultural barriers that impede SRHR.

Monitoring and Evaluation

- M & E is responsibility of the EARHN coordinating country.
- Is supported through reports and updates from country coordinators.
- The log frame is the basis for monitoring.

M & E con't...

- Indicators are systematically collected, monitored and learned from.
- Indicators are reported on during annual EARHN coordination meetings.
- The Log frame is used to assess the success of the Strategic Plan and will also be basis for evaluation after 5 years.
